Rules and Guidelines

Hours of Operation

The BAAM Athletic Center will operate as follows:

Monday - Thursday

8:30 am - 3:00 pm

6:00 pm - 10 pm

Friday - Saturday

8:30 am - 10 pm

Check in/Check out

All members must check in with the front desk associate using their membership card before entering the gym area. Upon leaving the facility all members must check out with the front desk associate.

Membership Cards

Admittance into the facility is not permitted without a membership card. A fee of \$5 will be charged to replace any lost, stolen, or damaged membership card.

Attire

During normal hours of operation, appropriate athletic shoes are required to enter the gym area. No street shoes, boots or sandals are allowed in the gymb area.

Food and Drink

During normal hours of operation, food and drinks are only permitted in designated areas. Food and drinks, including water, are prohibited in the Gym area. Failure to follow this guideline will result in removal from the facility.

Equipment Rental

Members may rent equipment during their visit. Only one item of the same type may be rented in a single visit. In order to rent any equipment within the facility, members must trade in their membership card. When the equipment is returned, the member will be given back their membership card. If the rented equipment is not returned by the end of operating hours, the member will be charged a replacement fee in the amount of the missing item. Members are responsible for all damaged equipment and will be charged a replacement fee in the amount of the damaged item. Outside balls and locks are prohibited.

Lockers

Members may utilize a single locker during their visit. Locks will be available to rent; the use of personal locks are prohibited. Overnight use of the lockers are prohibited; any items left in lockers overnight will be disposed of.

Conduct

Swearing, fighting, and derogatory remarks involving any other member or personnel will not be permitted.

Management of Building African American Minds, INC. may suspend or cancel the rights, privileges, or membership of any member in default under this agreement or whose actions are detrimental to the enjoyment of the center by other members. Any illegal activity will be reported to the authorities. Failure to abide by the center rules and guidelines will result in default.
